## WHAT IS AN INVESTIGATIVE CERTIFIED PUBLIC ACCOUNTANT (ICPA)?

ICPAs perform complex technical investigations with a high degree of independence. They may act in a lead capacity to direct or review the work of other certified public accountants (CPAs). ICPAs also provide technical support to legal counsel during litigation, provide expert witness testimony at administrative disciplinary proceedings, and other related work.
